Good afternoon all.

I think a question we should consider tho is do we need that many more zoom meetings per week? Right now, the area has at least one local zoom meeting up and running per day, and many days have multiple local meetings to choose from. This is in addition to all the other available zoom meetings across the country and world.

The meetings I've joined have not been very large, which leads me to believe that the number we have is appropriately serving our population

A first step maybe should be to try to find out how many hgs we have that really want to be using zoom and just don't have the computer skills to pull it off. If it's only a couple, it might make more sense financially to just help those couple meetings get up and running...

If the area was to purchase a zoom package, attached is a screenshot showing an idea for what might work. If we could have a single volunteer per day to be the host for meetings each week on that day, we could use just 7 pro hosts and that would allow for 100 person meetings.

Additionally, we can pay for a large meeting which would allow for things like a speaker jam up to 1000 participants. This feature is an add-on to a pro host, so we would need an 8th pro host to cover this feature.

So, at \$210, less than the price of renting a hall for a single event, we could conceivably cover the area meetings and special events. And if we felt the special events only needed a 500 person room, the cost would only be \$170.

I would be willing to host the Friday meetings, as that is my normal homegroup day. Heather is willing to host the Wednesday meetings as that is her homegroup day. And because we are in the same house, we would actually both be hosting meetings for both nights. So that would make possiblity for 2 simultaneous/overlapping meetings per meeting those nights.

If we can get other folks to volunteer other days, and ideally some that would double down like us and include either Saturday or Sunday, that would be great.

Please let's arrange a time to zoom and talk about. Given it's a monetary output and we don't necessarily have the ability to get the voting to handle this right now, I would even be willing to output for it ahead of time and put in a request after the fact at real area to get reimbursed at the risk of GSR's voting against. It's worth it to me, but let's discuss asap.

Also, we can have zoom training session for hosts to ensure all know how to secure their rooms and operate them fully.
