Convention: Motion passed to give back \$5 to the individuals who pre pre-registered from the last convention. Currently testing the registration link. Concerns that the chair is making decisions without the committee's conscience. This was brought to Tina's attention by other RCMs and Board members. The RSC needs to hear what is going on before any action can take place. Straw Poll to have Tina K. attend the Convention BOD meeting. 3 opposed out of the 9 RCMs.

Regional Delegate: Net literature income is still under the amounts set as allocations in the emergency budget but is slightly improved at approximately 18% under budget. Most expenses are under budget with the exception of legal expenses and in-house production along with the allocated expenses for Accounting and Technology.

Literature sales are rising gradually month to month but still nothing that we can use as data points for the second -year budget. As a result, it will be as speculative as year one was. The World Board will be discussing and reviewing the emergency budget draft for

year two of this Conference cycle at their upcoming 2 meetings and expect to have a draft to discuss in June.

The Loner IP: The project to revise this IP has not been started.

Issue Discussion Topics: The other project that has not really addressed is the IDT project.

IP for Women: WSC 2020 passed a motion to create a project plan to develop an IP for women.

We believe a better approach would be to update the Public Relations Handbook Chapter 6 (Criminal Justice) resources section and H&I Basics with more information relevant to current practices and methods for carrying our message that could include using virtual platforms and tools. RCM2: No report.

Policy: Rob reporting.

Several questions were asked of policy this past month regarding Special Events:

- What is SASE's current budget? Special Events policy concerning its budget was changed July 11,2019 to \$600.
- What is SASE's prudent reserve?

SASE's current prudent reserve is limited to \$3000, all monies above prudent reserve are to be donated to Area. This was changed in a July 11, 2019 motion.

During our meeting discussions regarding prior ticket sales from the spiritual breakfast (80 tickets were sold) and how Special events, without a chair, were attempting to reach out on social media platforms for those who purchased tickets

for the breakfast. Accountability was discussed, and provided an opportunity to learn from the past years events. We look forward to working with the new special events chair.

Sharing Session:

Bryan advised that church is willing to allow in-person ASC meeting in pavilion with social distancing guidelines – with masks and parking 6 feet apart. Jason discussed CDC guidelines updating that masks are not required outdoors. Bryan will check with his contact to see if they are changing stance considering updated CDC guidelines.

New Business:

Mandy made a motion that GSR's take literature issue back to home groups to discuss and vote on procedure moving forward next month.

Derek S advised his homegroup was trying to support the area by ordering through Mandy. Tom indicated that this does not support the area, but is taxing to literature chair. Aimie advised that her homegroup has been ordering directly from WSC during entire pandemic. She advised that it is quite simple, and there is no shipping on big orders. Derek S motioned that area stop fulfilling orders after this month. Heather D seconded. 8 in favor, 2 abstaining, 0 against; motion is passed and literature orders will not be fulfilled after this month.

Derek S requesting that minutes be sent earlier than currently done. Mindy advised that minutes will be provided in a timelier manner.

Mike advised that region discussed removing H&I handbook, as it is outdated.

Amy advised that she has recently read and it does not seem out of date to her. If literature is removed, what would be used?

Dylan indicated that sections of PR handbook under consideration as well.

Amy recommended that it be updated, but not removed during the updating process, as it allows people to having something to work from. Heather 2nd, but not an actual motion.
